Policies and Disclosures

Authorship and Acknowledgements:

The CRIB must follows the University Guidelines for Authorship (see below). No CRIB staff is required to be included in any publication as an author for any fee-per-service work, however we do require that we are given recognition in the acknowledgements section of any publication for any data obtained or analyzed via CRIB staff, instrumentation, software, or any other resources. Please use the following or similar language: "The authors would like to acknowledge that the following work (statement of work) was performed by the Johns Hopkins Center for Resources in Integrative Biology (jhmicrib.org).

Pass-through Services:

To ensure that all clients are aware of the most up-to-date information, pass-through services (running somebody else's samples in a collaboration) are not permitted without full disclosure and approval of the CRIB. Any and all collaborators must receive full disclosure of our offerings and prices and must receive a copy of our basic reports included with our profiling analysis directly.

Sample Preparation:

If a client wishes to perform his or her own sample preparation, we must receive a full copy of the protocol used. We recommend pre-approval of the protocol. The CRIB centrifuges all samples prior to injection to the mass spectrometer. If particulates are present, a nominal charge will be applied to each sample to cover the time required for transfer of samples to fresh tubes.

Internal Standards:

To ensure that the instrumentation performed properly, the CRIB uses deuterated internal standards to monitor quality control. If a client does not wish to use internal standards, the CRIB will not guarantee the results of the analysis and will not re-run the samples (see below).

Quality control guarantee:

The CRIB endeavors to provide the utmost highest quality of analytical services. In the case of a gross technical failure, the CRIB will re-run the samples (if sufficient material is remaining) up to two times at no charge to the client. In the case of special matrices (tissues etc.), the CRIB will only re-run samples up to one time at no additional charge. For clients opting out of internal standards, the CRIB will not guarantee results and cannot offer to re-run samples due to lack of sufficient information for troubleshooting.

Johns Hopkins Authorship Guidelines:

A. Authorship

- 1. All persons designated as authors should qualify for authorship, and all those who qualify should be listed.
- 2. Authorship credit for original, research-based works (in any medium) may be based on 1) substantial contributions to conception and design, or acquisition of data, or analysis and interpretation of data; 2) drafting the article or revising it critically for important intellectual content; 3) sufficient participation in the work to take public responsibility for appropriate portions of the content; and 4) final approval of the version to be published. Authors should meet conditions 1, 2, 3, and 4. Other contributions such as provision of a key reagent, or collection of data may also be considered as long as conditions 2, 3 and 4 are met.
- 3. Authorship credit for reviews or commentaries not based in original research should be based on conditions 2, 3 and 4.
- 4. Acquisition of funding, collection of data (for example, from a fee-for-service core facility), or general supervision of the research group (e.g. by former or current mentors not directly involved in the conception or execution of the publication), alone, does not justify authorship.
- 5. Financial and material support should be disclosed.
- 6. "Ghost-writing," a practice whereby a commercial entity or its contractor writes an article or manuscript and a scientist is listed as an author, is not permissible. Making minor revisions to an article or manuscript that is ghost-written does not justify authorship.

Increasingly, authorship of multi-center trials is attributed to a group. All members of the group who are named as authors should fully meet the above criteria for authorship. The order of authorship on the byline should be a joint decision of the co-authors. Authors should be prepared to explain the order in which authors are listed.

B. Contributors Listed in Acknowledgments

All contributors who do not meet the criteria for authorship should be listed in an acknowledgments section, with written permission where consistent with journal guidelines. Because readers may infer their endorsement of the data and conclusions, all persons must give permission to be acknowledged.
