## 2019 UIC Ingenuity Pathway Analysis (IPA) usage agreement

Qiagen's Ingenuity Pathway Analysis (IPA) is a commercial pathway and network analysis tool for systems biology analysis, with applications varying from biomarker discovery, elucidation of biological mechanisms, hypothesis generation, and literature review in a variety of biomedical applications. Access to an institutional license for IPA is administered by the Research Informatics Core (RIC) and the Research Resources Center (RRC) on an annual fee-per-user basis. Our license permits unlimited user accounts, but only one concurrent user. To preserve fair access for all UIC researchers we ask that each user adhere to the usage limits below. Failure to adhere to these limits may result in warnings and/or loss of access to IPA without refund of access fees.

NOTE: In 2019 Qiagen is waiving the concurrency limit for the first 6 months of the license. Therefore, from January 2 through July 2 2019, there will be NO limits to usage per user, and no requirement to reserve time on the resource calendar. Usage limits and calendar reservation requirements below will be enforced beginning July 3 2019.

## Usage limits:

- No more than 4 hours per day.
- No more than 8 hours per week.
- There is no annual hourly limit.
- If special circumstances require more time than the limits noted above, please contact us at <a href="mailto:cribioinfo@uic.edu">cribioinfo@uic.edu</a> to make arrangements for a longer reservation.
- Time must be reserved on the IPA resource calendar under the username used to log in to IPA. Failure to book time on the resource calendar prior to use may result in termination of your IPA session. The resource calendar is available at:

Calendar reservations should be made with the same username and RRCAN used for IPA registration. There will not be any charges associated with reservations.

- Registered users are ultimately responsible for the usage of their account, even if sharing their login credentials with others.
- Terms and limitations may be updated as needed and users will be notified of any changes.

## Features include:

- Unlimited annual usage of UIC IPA, subject to daily and weekly time limits noted above.
- Unlimited uploads to a private account for each user.
- Annual free IPA workshop, presented by Qiagen, hosted by RIC.
